e were children of the new city, children of the all night party, children of a new dawn celebrating the solstice as our ancestors before.....

we dance madly and stop from exhaustion; speak madly of eco-disaster, state repression, consumer lie democracy, our visions for future earth; speak madly of E, hash, speed, acid, why we do them, why we don't... we relish the night and demand a better tomorrow, a better today....

three of us in a battered old churning unpredictable opel, caught by the wildness of a solstice weekend. Out of the city, down the main road... men with a mission — to find The Party in the Bog. "Turn left at a pub about three hours out of Dublin, go up that road, and well, you'll find it" Some directions! So we turned left and up the road and there was a couple walking minding their own business in the twilight night. "Pull in, we'll give them a lift and shur maybe they'll know where we're going." So we did and they did. "I was down at it last night", said the bloke, "fucking great craic, there must be 2,000 people below I'd say. We'll get out here. Take your first left, go straight for ages, turn left at a sort of a T-junction and then right, go on down there for ages and yill find it." Nice one, deadly, thanks.

half hour of boreens, grass in the middle, round in circles, huge pot-holes..... around a bend and an opening in the road. Twenty or more cars reversing, forwarding, getting in each others way; three blocked entrances which seemed to lead nowhere. A car filled with obviously locals crept by and serious sullen faces stared out at the clatter of cars and funny haircuts invading their safe passage home.

omeone eventually knew where we were going. A line of cars, a procession, bouncing on a bog road, sharp left and no ditches. Moonscape road now, no tar. A scene from Mad Max opened up. German troop carrier, grass growing through it. Old tyres and

a stripped down van. Caravans, converted estates, a horse wagon....
many and varied weird vehicles lined the "road". A few kids whizzed by the headlights on bikes laughing. On for what felt like a mile through a looney line road in a bog, solstice weekend.

#### It's a mini Glastonbury

We parked up. Lights and wafts of music in the distance. As we got closer I could see three markees, people milling around, a flourescent chinese dragon. "Ya hoo," says I," it's a mini Glastonbury." Over a small dusty bridge and under wooden arches. Group of blokes with a bucket asking for donations to "keep the genny's going, come on chip in a few quid, got ta keep the party goin'." If one had it, one did. A free party. A party not for profit.

about 250 bods bouncing to boombastic jungle... a small caf in the corner, "Soup 40p, Tea/coffee 20p" Strolled on. Past a group chilling on the ground, big hellos big smiles... round here there ain't no trouble, hassle or grief. There is no law, no police, no jail, no tax, no leader, no authority... simply voluntary group co-operation — Respect and self-responsibility. The most intelligent way to organise society, the most beautiful way to organise a party — ANARCHY.

ent to the next markee, hard house... about 300 heads and the music up up up again where the tweeks and bleeps and cyber wails of the tunes swirl round the big top and bring us up up and on to the highs and wilds and voyage of freedom inducing white mind meditation dance.

ut of there and on I waltzed.
Happy smiling people abound. A mischievious sense of well being permeates the air. Hee hee hee, no closing time, no cops, just us, party lovers paradise. Into the biggest markee now. Blistering blinding blizzard techno assault of the senses.

Teeming mass of bodies lepping laughing loving life. Bounce through the crowd, must be over 600 in here. Up near the front in the middle. So many people... the greatest rave I was ever at. These people are seriously

going for it. Loads of eye contact. people buzzing off each other, doing silly dances, wild ceile dances, rave a go, anything goes. Total communication, life celebration. Two walls of blasting speakers. Dance stimulation high on lights... trippy swirly circus show lights and the strobe ha ha... roll on the dawn let's dance for life and for everything and nothing and everyone and no one and it's all good and it's all bad and in here in the dance it all makes sense .... we laugh n' shout n' roar n' whistle surfing the wave of music crashing in around us, spinning us out krack-a-boom splash and up to the crest, surf that tune.... and we're all in this thing called life together. Total communication, life celebration. Oh and it's the solstice too... what a night for a party, what a party for a night.

ut the back of the big markee was a chill out space. A hundred or so people sitting, chatting and smoking, encircled by trees with flourescent multi coloured drapes and shapes. A huge white bird fluttered in the breeze above our heads-Art. Over in the corner, a bar with a counter selling perfect night time temperature stout by the bottle at a pound a go.

#### Loud and Proud, Dancy and Free


I lay back on the grass, stout in hand. looked around, bliss. A solstice party on a green patch in the middle of a bog.... No commercial exploitation, no trouble, no security men, it wasn't advertised yet there's over a thousand people here .... This is truly amazing, how can it happen? Well maybe it's because, well maybe most of the people here have something in common...... You didn't have to pay in here, but you would if you could..... 'cos,.... The myths have been stripped bare, the bungalow and picket sicket white fence car and mortgage (mort-death, gage-pledge) noose has been seen... material success and stock piles of the latest gadgets and gimmickry rejected... we want friends, uncensored dance. uncensored communication, no sexual taboos, equality, a life beyond the chains of economics, a life beyond atomaton worker, fuck your target marketing the planet is dying.

culture

o hell with your ISEQ index up two points bullshit, stick your dramatic fall in the seasonally adjusted increase in unemployment doublethink. We have not been put on this earth to be ordered around, we have not been put on this earth to be shrinkers and shirkers and

skivers, nor to bow our heads in humble servitude, we are loud and proud, we are dancy and free .... A NOW GENERATION, CHILDREN OF THE PARTY....

eap your dancing boots on, your eyes and ears open it's Summer, outdoor party season is on. Perhaps you'll hear where the party is, perhaps you won't, if you do hear, GO DANCE. "Here and now boys and girls, here and now."



nd off we went about 20 of us, full of high spirits, some full of other of things, on the late bus to the Wicklow mountains for the first outdoor free party of the Summer. A miserable persistant rain beat down in the pitch black night as we

walked along the road looking for the carpark that was to lead us to a path up the valley and into party paradise.

I,000 people from all over the country arriving for a free festival to celebrate — to celebrate doing it in the open for free — there was going to be fire jugglers and U.V. performance, at least two sound systems, dancing creatures from Celtic legend and lumps of Art hanging from the trees — the stuff of free parties — celebrate not having to put up £1,000 for the use of a venue, not having to pay £300 to a dj. not having to pay £10 to get in a door, not having to swim round drunken brawling bodies streaming simultaneously from night clubs on the way home, not having to work within the confines of property prices and privileges.

Uniforms

Little did we realise the mountain was to be crawling with: cops, cops and more cops. Four Garda stations were represented and from party goers reports there was at least 80 of them. They'd set up in the car park we were heading to and on the smaller approach roads to the party, while about 40 of them descended on the party. Eight people were arrested, two for organising the party, the rest for small amounts of personal ecstacy and hash.

o be fair to the Guards they didn't ruff people around while searching, but this is what they did do.... Descending en masse to the party site early on in the night when there was only 80 or 100 people there,

both plainclothes and uniform guards entered the old ruined building where the sound system was happily blasting away. They cut wires powering lights and decks, they ripped wires from the generator and spilt the containers of petrol intended for the genny on to the forest floor. They then searched everyone.

amage to private property?
Damage to Dept. of Forestry
land? Invasion of a troublefree
party? Guardians of the Peace? As
people came out of the ruin one
by one, a dour suppressing aura
of fear and suspicion filled the forest. Flashlights in your face, people talking to you asking stupid
questions, more flashlights surrounding the site, no one knowing
who was plainclothes who was not.

### Dancing at the cross Roads

People have being drinking and carousing and partying at this spot for years and years. As one local who lost his temper when told to stop singing so loudly by a guard complained, "Look I've been coming up here with my friends for years to have a drink and a laugh, before that my father took me up here to see the view. now you tell me I can't even fucking sing here! Who's going to hear me? We're in the middle of a bloody forest not bothering anyone. Why don't ye all just fuck off, we're not doing anyone any harm." Then his friend piped up, "Come here and answer me this. What was the point of kicking out the English and getting our country back if we can't even have a party in a forest. This is just the same as dancing at the cross roads and that was banned by the English."

he suspicious air of conspiratorial whispering was broken and a number of guards in their early 20's started talking to the party goers. Their point was that they wouldn't be here at all if it wasn't for the drugs. Although the talk on the night was of 2,000 ecstasy being found, the Irish Times said there was 100 seized -1wonder! The main point the guards and the mainstream media are missing, is that this is about more than drugs and it is not a simple naive thing called "a drugs party." It is about people putting in time and effort for free to put on a party, it's about why people would trudge through a rain soaked forest in the dead of night to experience the unique atmosphere at these special cultural events. People organise parties for old age pensioniers for free, people organise local sports days for free, people organise surprise wedding anniversaries for free so why all the suspicion and name calling when people organise a free party with the popular music of the day? Society always has a monster to occupy the minds of the masses while those in charge of production, police and communication maintain the status quo be it Communism, terrorism, the god of thunder, inflation, invasion and now drugs. The recreational drug use culture is so prevalent that the language, images and music from the culture are being used to sell products. (eq. The Bank of Ireland's slogan for young people "Get Sorted". ) However, the main point is that the Free Party Culture is yet another manifestation of a worldwide selfdirected cultural revolution towards a more humanitarian and highly evolved society.



being antagonistic is not a part time job..."God is dead, Marxism's dead, liberalism never existed, and to be honest I was not feeling too good myself.""Then I found GoD and realised that FUN IS MORE IMPORTANT THAN EXISTENTIAL ANGST."

afe, bookshop, performance, theatre, bad advice, exciting politics, urban adventure, unending drama, tragedy, laughter. We were born on a sunny day in August on the edge of the Liberties and a stone's throw from Temple Bar, our childhood has been a stormy affair. Organised by a voluntary selfmanaged collective, we seek to open up the north west passage to experience which prioritises pleasure and delights in flux...

n a time when money has replaced God as the popular religion, we try to mantain the possibility of access to all. Events are free and the books are there to be read, not only admired, although an occasional purchase does not cause any displeasure. We serve delicious coffee and the finest of pasteries and dishes, at reasonable prices. he GoD Collective espouse no individual ideology and affirm confidence in difference, we seek to provide a free and uninhibited forum for the exploration of marginalised or subversive

currents running through culture, politics, relationships, society. It seeks to be non hierarchical, inclusive and progressive. The space is collectively run by a large group of unpaid and suspicious people, who co-operate around the simple agenda of the maintenance of the shop as a machine, a liberated space. We show films with a bias towards local directors and particularly those working with low or no budget. There's been films in Irish, documentaries on the alternative music scene, the road protesters in England, the life of Pat Tierney and on the visit of the USS JFK warship last Summer. They pop up and do their vital blend of theatre, performance, spontaneity, wicked humour and serious sounds from the Decks every now and again at venues around town on a non regular basis too, check them out. The Soul Gun Warriors say "Welcome to Escape Routes, a series of excursions towards a fresh theatre for a fresh audience, (We have a space + in it we put people — you, us. DJ plays some records, + we start a conversation, many conversations...) free of the formality of the conventional theatre experience. We use the informality of the club space and it's invigorating musics as the set-

ting for new work. (We take this opportunity to thank the DJ who has shown us how to be active consumers, rescued us from corporate choice... Thank you to all the Medicine Mixers who have inspired us) The Escape Routes concept is a reconfiguration of theatre in an informal programme, creating a fresh style (We aim to scratch + mix our theatre, making something new + fresh + now, as the DJ does) A fresh repertoire, (inspired by comic strip, comedy, cut-up and B-Movie culture) A new set of Heros and Heroines.

Escape Routes aims to demonstrate the immediacy and relevance of theatre to a modern non-theatre audience. (It's time to be the heroes of our own movie — The only revolution worth having is your own."





emp can be used to make clothes, houses, food, medicine, paper, furniture and rope. So why don't we grow it? Let's look at some of the issues....

hat is Hemp? Botanically, hemp is a member of the most advanced plant family on earth. It is a dioecious, ie. having male and female and hermaphroditic (male and female on the same plant) woody, herbaceous annual that uses the sun more efficiently than virtually any other plant, reaching a robust 12 to 14 feet or more in one short growing season. It can be grown in virtually any climate or soil conditions on Earth, even marginal ones

### But Isn't Hemp the Same As Marijuana the Cannabis plant?

Yes and no. "The Cannabis Hemp Plant" can be bred in one way to make paper, clothes etc, and bred in another way to make it good for smoking or as a medicine. The visual similarity between the different strains of the Cannabis Hemp Plant (Hemp and Marijuana) was used as an excuse by industrialists in the U.S. in the 1930's to have it made illegal so they could make things out of oil instead of hemp.

arijuana - is grown and bred to maximise the flowers, buds and upper leaves which contain a group of chemicals called cannabinoids, of which the most psychoactive is Tetrahydrocannabinol (THC). It is this concentration of THC which produces the effect of "being high" on Marijuana or on hashish which is made from the Marijuana plant. It is grown sparsely so that plants are bushier.

emp — is bred to maximise stalk fibre, it is sown tightly so that the plants compete for the light and shoot straight for the sun. All resources go to the stalk so only the top of the plant is leafy. There is a negligible THC content — you could smoke a field of it and not get "high."

### History of Use of Hemp

The body of literature on the subject (archaeologists, anthropologists, philologists, economists, historians, etc) is in general agreement that, at the very least: From more than 1,000 B.C. until 1883 A.D., cannabis hemp—indeed, marijuana was our planet's largest agricultural crop and most important industry for thousands of products and enterprises; producing the majority of earth's fibre, fabric, lighting oil, paper, incense and medicines, as well as a primary source of essential food and protein for humans and animals.

★ The Declaration of Independence of the USA in 1776 was written on paper made from hemp.

★ Until the prohibition of Marijuana, all jeans were made from hemp.

★ 90% of all ships' sails from at least the 5th century B.C. to this one were made from hemp.

\* King Henry the eight and Queen Elizabeth I required all English farmers to grow hemp.

★ Benjamin Franklin started one of America's first paper mills with Cannabis Hemp. This allowed America to have a free colonial press without

having to beg or justify paper and books from England.

★ In Virginia USA, during several periods of shortage from 1763 to 1767 farmers could be jailed for not growing it.

★ The US census of 1850 counted 8,327 hemp plantations, each a minimum of 2,000 acres.

In 1942, after the Japanese invasion of the Philipines cut off the supply of Manila (abaca) Hemp, the US government distributed 400,000 pounds of cannabis seeds to American farmers, who produced 42,000 tonnes of hemp fibre annually for the war effort untill 1946. The Fibre was used to make shoes, uniforms, parachutes, tents, ropes etc.

### Hemp — The Big Challenge To The World: Try to Prove Us Wrong.

In his book "The Emperor Wears No Clothes", Jack Herer issues this challenge to the world to try and prove him wrong: "If all fossil fuels and their derivatives, as well as the deforestation of trees for paper and agriculture, are banned from use in order to save the planet and reverse the greenhouse effect: Then there is only one known renewable natural resource able to provide the overall majority of our paper, textiles and food, meet all the world's transportation, home and industrial energy needs, reduce pollution, rebuild the soil and clean the atmosphere, all at the same time, our old stand-by that did it all before, Cannabis Hemp."

hen Herer put the facts and the above challenge to Steve Rawlings, the highest ranking officer in the U.S. Department of Agriculture who was in charge of reversing the Greenhouse Effect, at the USDA world research facility, in 1989 — Rawlings response was "You know, I think you're right. Hemp could be the plant that could do it. Wow! That's a great idea." Herer added that hemp could be used to make everything from dynamite to plastics and that i acre of it would replace 4.1 acres of tress. However, Mr Rawlings then said, "It's a wonderful idea, and I think it might work. But of course, you can't use it." "You're kidding. Why not?" "It's illegal. You cannot use something illegal... No, not even to save the world."


### Hemp V's Sitka Spruce Trees for Ireland

All over Ireland one sees plantations of Sitka Spruce trees, the one that looks like a christmas tree. This tree is killing our country.

ecause of the high acidity levels collected in the needles, the range of plant life is not as diverse as in broadleaf forests, while the variety of wildlife is diminished. The fish population is dead or dying in the rivers and streams close to Sitka Spruce plantations because of the high acidity levels in the run off from them.

to 25 years after planting. After the third harvest, it takes up to 200 years for

the land to return to it's original state. HEMP can be harvested three times a year and the land can be immediately returned to use for grassland or arable crops.



## And Now, the amazing facts of how and why the Cannabis Hemp Plant became illegal

ince 1937, about half the forests of the world have been cut down. If Hemp had not been outlawed, most would still be standing, oxygenating the planet, in 1937 the U.S. government placed a prohibitive tax on the hemp plant, effectivly making it illegal. Up until 1937, dynamite and the simple plastics (celluloid, acetate and rayon) were made out of hemp. This was done by nitrating the cellulose fiber of the stalk. 80% of the hemp stalks weight is in the 77% cellulose hurd. The highly respected "Popular Mechanics" reported in 1938 -"Thousands of tons of hemp hurd are used every year by one large powder company for the manufacture of dynamite and TNT."

he company was DuPont and in the 1st World War they provided 40% of the munitions for the Allies. In the mid to late 30's the company patented the process of making plastic and synthetic fiber out of oil and coal. Despite the invention in 1937 of a state-of-the-art mechanical hemp fiber stripping machine and a machine to conserve hemp's high-cellulose pulp which would mean much cheaper faster hemp production, the company's 1937 annual report urged continued investment in it's petro-

chemical products and told shareholders it was anticipating "radical changes" from "the revenue raising power of government... converted into an instrument for forcing acceptance of sudden new ideas of industrial and social reorganization."

he DuPont company from 1928 to today only used two banks. One of these banks in 1937, the Mellon Bank of Pittsburg, was the sixth largest in the U.S. It's owner and largest shareholder was Andrew Mellon who in 1931 became the Secretary of the Treasury to President Herbert Hoover. In 1931, Mellon appointed Harry J. Anslinger, his future nephew-in-law as chief of the Federal Bureau of Narcotics and Dangerous Drugs (FBNDD), a post he held until President Kennedy fired him. The FBDNN has since evolved into the Drug Enforcement Agency (DEA). (The DEA remember, as reported by the Sunday Busines Post and referred to by the Sunday Tribune, were the ones who approached Gardai and facilitated them in the importing of a 40 foot trailor of Hashish into Ireland in 1995, which they then drove from Cork to Urlingford where it was "discovered" in a high profile "sting opperation".)

nslingers job was to convince politicans and the public of the urgent need to illegalise the evil marijuana. Virtually no one in America other than a handful of rich industrailists knew that their chief potential competitor, hemp, was to be outlawed under the name marijuana. Companies involved in oil, chemicals and paper stood to gain the most by hemp's illegalisation. One among them was William Randolf Hearst. In 1937 he owned the majority of U.S. newspapers and had an enormous timber business. The last thing he needed was a cheaper, more environmentally friendly substitute for his trees. His newspapers carried hysterical stories about the evil marijuana — Hearst took the obscure Mexican slang word "marijuana", ignored the word "hemp" and the scientific term "cannabis" and referred to "Marijuana -The Mexican Killer Weed" — it was he who put the word into popular use. Hearst was an insidious rascist, his headlines screamed of the "lazy pot-smoking Mexican" and protrayed Negroes and Mexicans as frenzied beasts under the influence of marijuana, who played anti-white "voodoo satanic" music (Jazz) and who heaped disrespect and "visciousness" onto the white readership.

n the U.S. congress, Anslinger was the chief witness during the debate to place the prohibitive tax on "marijuana". The majority of his factual evidence consisted of stories from Hearst's newspapers. The American Medical Association

representative was shocked at what was happening and realised just "two days before" the congressional hearing, that the plant they intended to outlaw was in fact one and the same as the medically known cannabis — the benign substance used in scores of illness for over 100 years in America, with perfect safety.

han Clark, in "The Emperor Wears No Clothes" says — "The Standard fiber of world history, America's traditional crop, hemp, could provide our textiles, paper and be the premier source for cellulose. The war industries — DuPont, Allied Chemical, Monsanto, etc., are protected from competition by the marijuana laws. They make war on the natural cycle and the common farmer."

### Medical Uses Of Hemp

ast November the U.S. states of California and Arizona voted to legalise the use of the high THC content strain of the Cannabis Hemp Plant ie. Marijuana, for use by people who could benefit medically from it's use. "Marijuana is one of the safest therapeutically active substances

known to man", said the DEA's administrative law judge, Francis Young, in 1988 after taking medical testimony for 15 days. Various medical bodies in the U.K. have called for it's legalisation for medical use as has the highly respected "Lancet" magazine.

★ Cholesterol. Hemp seed oil has the highest concentration of essential fatty acids of any plant. It is especially high in Omega 3 and 6, which unclog arteries and dramatically lower cholesterol levels.

★ Asthma. 80% of asthma sufferers could gain benefit from smoking marijuana. "Taking a hit of marijuana has been known to stop a full blown asthma attack" — Dr. Donald Tashkin.

★ Glaucoma. Cannabis smoking would benefit 90% of the victims of glaucoma. It is two to three times as effective as any current medicines for reducing ocular pressure. Cannabis has no toxic side effects to the liver and kidneys, nor is there any danger of the occasional death syndromes asociated with the legal pharmaceutical glaucoma drugs/drops.

★ Tumors. The Medical College of Virginia discovered that cannabis is an incredibly successful herb for reducing many types of tumors, both benign and malignant (cancerous). An apparent medical breakthrough occurred in 1975 and successful tumor reductions were recorded, orders were handed down by the DEA and the National Institute of Health to defund all further cannabis/tumor research and reporting.

★ Chemotherapy and Aids. "Marijuana is the best agent for control of nausea in cancer chemotherapy," according to Dr.

Thomas Ungerleider, who headed California's Marijuana for Cancer research programme from 1979 to 1984. This is also true in AIDS and even in the unsettled stomach common in motion sickness.

★ Epilepsy. "Marijuana... is probably the most potent antiepileptic known to medicine today," reported the Medical World News in 1971. 60% of all epileptics could benefit as a cannabis users' epileptic seizures are of less intensity than the more dangerous seizures experienced by users of pharmaceuticals.

★ Multiple Sclerosis. Smoking cannabis has proven to be a major source of relief for multiple sclerosis victims who can carry on relatively normal lives while using it.

★ Stress. Cannabis lowers blood pressure, dilates the arteries and reduces body temperature by an average of half a degree, thereby relieving stress. Unlike Valium, cannabis does not potentiate the effects of alcohol. It is estimated that cannabis could replace more than 50% of Valium, Librium, Thorazine, Stelazine, other "-zine" drugs and most sleeping pills.

★ Other Uses. Cannabis has also being shown to be benefical for back pain, muscle spasms, to reduce saliva, increase appetite and cure herpes. Also used in the treatment of HIV/Aids patients - stimulates hunger, slows immune system decrease.

Although Hemp does assist in the treatment of these conditions it is not necessarily the only or the best treatment

s Herer says in his book, "We don't put our doctors in charge of stopping violent crimes. The police and prosecutors should not be in charge of which herbal therapies people may use to treat their personal health problems". If you find it hard to believe that the government, the mainstream media and the large

companies suppress this information, another example of the inhuman levels these groups can reach in order to make patented medicines check out issue two of **Catalyst** for a report on Essiac — the herbal remedy which has been known to cure cancer, arthritis and ulcers, relieve pain from a variety of illnesses and boost the immune system.

### Hemp — Who's Growing in Ireland?

Is There a Market? Where To Get A Licence, There's Even Grants Available.

esearch scientists at Teagasc, in Oakpark, Co. Carlow have been growing a low THC version of the world's favourite plant — The Cannabis Hemp Plant, for the past few years to research a number of lucrative uses.

very fast it creates a large biomass which can be burned to create electricity. The ESB are planning a demo energy unit in the midlands, where they will burn various waste matter. Yes, ecofriendly electricity from the hemp plant is a possibility here in Ireland.

im Crowley at Teagasc told Catalyst,
"We are burning a very good
product." He points to its excellent
paper making potential — it generates
four times as much paper as a compara-

ble area of forest: "There's a lot of work going on in Sweden, they're interested in using it to replace wood in the pulping process. It can also be chopped up and used as horse bedding—it remains dry and can be easily shoveled." It's toughness makes it a successful building material: "Medite in Clonmel are buying balls of hemp from us for a test run. They're interested in using it to strengthen their plywood products while reducing weight. It can also be used for composting to replace peat products," says Crowley.

So far there's very little hemp business in Ireland, although a hemp shop was open in Galway during the Christmas season and did very well selling clothes. Someone in Clare is importing hemp from Eastern Europe to make clothes.

RTE Radio from Cork did an interesting programme a few months ago, where it was discovered that paper money and teabags are made out of hemp.

he hemp produced at Teagasc contains only 0.3 percent THC, which is impossible to get high on — marijuana contains 5 to 12 percent THC. Despite this, Teagasc were tipped off about a possible raid on the plantation. Unscrupulous dealers would attempt to pass off the hemp as smoking quality marijuana.

"We'd like to plant earlier, but we need to avoid the frost, which you can get as late as May," says Crowley. They sow about 500/600 plants per square metre, and the low THC seed costs about £50/60 per acre. England has at least one successful, large scale producer of hemp, Hempcore. They have 2 to 3,000 acres. They got into the market through horse bedding, where much of the hemp ends up. They also sell it for paper to the ciga-

rette companies who use it to make the paper for regular tobacco cigarettes. The French hemp industry is also well established. Cannabis cultivationin Ireland is covered by the Misuse of Drugs Acts, 1977 and 1984. It's worth noting that it's legal to have seeds (available from many petshops) and that the stem of the plant is also legal. The Department of Health are the ones who issue licences to grow hemp. They look for, among other things, a signed up end user, and they are pretty strict about how the product is disposed of. Word is that they like the farm sites to be away from main roads and busy areas.



## Teagasc Scientists look to Biofuels

Teagasc scientists are looking into various biofuels - biodiesel and ethanol (basically alcohol) as a petrol substitute. There is a possibility that biodiesel production could start soon, selling to government agencies like the OPW. Cork County Council currently have vehicles on the road which are powered by biofuels.

Biofuels are a renewable resource, fossil fuels aren't. Biofuels emit much less pollution - car pollution is responsible for most air pollution.

Switching cars to run on alcohol and plant oil would be relatively cheap and would massively cut down on pollution. Fossil fuels can be diluted with 10 to 15% biofuels and used in existing cars. Some diesel engines can run on pure biodiesel, others can be modified. Petrol engines need to be modified at a factory to run on pure alcohol. Henry Ford preferred to run his early cars on ethanol, but was won over by the then cheaper fossil fuels. In Western Canada, Mohawk Oil has grown rapidly by aggressively marketing its environmentally friendly fuels, calling itself "Mother Nature's Gas Station."

Glending forest near Blessington in west County Wicklow is a beautiful mixed woodland habitat for deer, rabbits, invaluable resource - a place for forest strollers, nature lovers, orienteering and jogging. Beside the wood there is a

oadstone Dublin Ltd. ( asubsidary company of Cement Roadstone Holdings) have a sand and gravel quarry beside Glending which has eaten its way into the forest and continues to threaten it. One local councillor said the quarrying was "turning a major local amenity into what resembles Brazilian rainforest destruction." The Department of Energy sold a large portion of the forest to Roadstone. Blessington Heritage Trust and the Blessington and District Community Council have been actively campaigning for years to save the forest.

### The Sale of the Land


In 1990, the Department of Energy owned the land and forest consisting of 182 acres. 35 acres, which includes the ring fort are now in the hands of the Office of Public Works (OPW). In 1990 the Dept. of Energy decided to sell the remaining 147 acres with its large reserves of sand and gravel. An

independent consultant was hired by the Dept. to advise on the disposal of the site and in April 1990 they suggested that tenders be sought. The consultants were Kieran O' Malley & Co., a consultant regulary used by CRH. No advertisements or requests for tenders were made when the Dept. was informed of a bid by Roadstone to purchase the site. The land was sold in 1992 to Roadstone Dublin Ltd. for £1.25 million (£im. for the land, £250,000 for the trees).

iam Kavanagh T.D. (Lab., Wicklow) in a Dail Question recently asked the minister for Agriculture, Food and Forestry, Ivan Yates, to explain how Roadstone were sold the land given that it had not been put to public tender and also wanted to know if the Department was aware of other: bids. In his response Minister Yates stated, "In April 1990 the independent consultants suggested that the Dept. of Energy might be best advised to invite offers by tender for the sale of the land. However following an offer for the property by the first company mentioned by the Deputy (Roadstone) the Consultants subsequently advised in October 1990 that it would be most unlikely that any other party would be able to match an offer from that company and strongly recommended that the sale to that company be pursued". He finished by saying, "the then Minister (for Energy, Bobby Molloy P.D. Galway West) was satisfied that the State received a fair price for the sale of the property." The chairman of CRH at the time was Des Traynor, the man mentioned recently in the Dunnes Tribunal as having approached certain individuals looking for money on behalf of C.I. — Make your own mind up!

### Archeological Remains

Frank Corcoran, chairman of the Blessington Heritage Trust said, "even if the ring fort is not touched, it would be left isolated on an artifical peak in the middle of a worked out quarry with its original setting completly destroyed."



### The Company Record on Site

In 1993 Roadstone quarried 67,000 tonnes of sand and gravel without planning permission, in an Amenity/Forestry land zone and had not completed an Environmental Impact Study. Roadstone Dublin Ltd. was taken to court by the Wicklow County Council and the company made an undertaking to cease unauthorised development.

★ In 1970 Roadstone recieved quarrying planning permission for an adjacent piece of land with three conditions. They are still not in compliance with two of these: To plant 10,000 trees on the north western boundary and to retain a 70 yard boundary of trees to the south east, facing the town.

The OPW has confirmed that to date, two listed archeological sites have been destroyed by quarrying on Roadstone land in the area of Blessington. (Yet the OPW made no objection to the sale of the land to the company.)

espite the company's record in the area and the 1,400 objections submitted by locals, Wicklow County Council in July 94 went ahead and voted to chage the zoning for the area in question from "amenity/forestry" to "quarrying".

### GI. ENDING FOREST

feral goats, squirrels, kestrels and goldcrests. For the people of Blessington and Naas and the surrounding area it is an ring fort built at least 2,500 years ago, where bronze age artifacts have recently been unearthed by archeologists.

n an archeological report commissioned by the Blessington Heritage Trust (BHT) on the Glending Ridge, expert Eoin Grogan said, "It is possible that further archeological remains occur on the ridge top. A more thorough investigation on the ridge would seem advisable, particularly as undated earthworks do survive."

s well as the ring fort now in the hands of the O.P.W., he pointed to a 12th century Viking Defensive Site which gives a panoramic view over the surrounding countryside and overlooks an ancient cross roads; the North-South Slighe Cualann and the West-East Road from Celtic Leinster to Wicklow harbour. Quarrying would destroy both the Defensive Site and the wonderful views enjoyed. Mr. Grogan also made note of the 2 to 3,000 year old man made ridge in the woods.

he Viking Defensive site is located in a deerpark in the forest, which was created under royal licence from King Charles the Second in 1669 by Archbishop Boyle, the founder of Blessington. The pre-1700 boundary wall which surrounds the deerpark, part of which has been destroyed, has yet to have a preservation order optit

### The Battle Continues

The people living in the Naas-Blessington area are determined to keep their Glending wood and have had many demonstrations and petition signings over the past few years. In 1995 they held the Blessington Heritage Festival to raise the consciousness of the importance of Glending as an amenity. The festival was attended by Riverdancers Annuna, Kevin Conife of the Chieftains, Ronan Brown (uillan piper), Cruachan and Prayerboat.


n January 8th this year Roadstone applied for planning permission to quarry their land in Glending forest. They were informed by the planning authority that a large portion of their existing quarry

adjacent to the site has no planning permission and that they must apply for permission of retention of illegal quarrying. The deadline for this application was April 25th. No application was made.

owever, given that the County Council appear to be bending over backwards to satisfy the financial concerns of Roadstone, i.e. no court proceedings against illegal development and snap changes in land zoning against local wishes, there is no guarantee whatsoever that the council won't hand Roadstone planning permission and tree felling licences prior to the acceptance of retention of illegal quarrying.

### Toxic waste incineration in Clare

A week before Christmas, last year, permission was granted to Roche Ireland (formerly Syntex) to burn toxic waste at their factory in the small town of Clarecastle, a few miles from Ennis. The licensing authority, the Environmental Protection Agency (EPA) gave the go ahead for the incinerator, after local people had campaigned for over 18 months for the plan to be dropped.

Roche Ireland manufacture anti-arthritic drugs but in so doing use highly toxic chemicals and create toxic waste. Many of these chemicals are carcinogenic, and some have been recently identified as hormone disruptors. For nearly 20 years, Roche have been allowed to operate in Clarecastle, with no limits set on what they released into the air and into the Fergus River, a tributary of the

Shannon. In 1992 when the EPA was set up, there was hope that the state was going to protect the environment. Clare Alliance Against Incineration (CAAI) campaigned to stop Roche from building their incinerator, illustrating clearly that communities must continue their fight for the environment despite the existence of a Statutory Body whose job it is to protect the environment. CAAI, supported by Greenpeace, followed every official means of objecting to Roche's incinerator. They objected to the local Planning Authority, Clare County Council, but because of the absurd nature of the system the County Council were not allowed consider any of the potential environmental impacts of the incinerator in making their decision on whether to grant planning permission or not.

#### **EPA Act**

The separation of the environment from the plannning process only came about in 1992 with the passing of the EPA act. To divide and pigeonhole the responsibilities involved in protecting the environment thus, is a retrogressive step, as it negates an holistic consideration of the environment. Another major weakness of the EPA Act is that no thorough system exists for considering the effects of proposals such as the Roche incinerator on human health.

#### Oral hearing sham

The CAAI made submissions and paid £100 to detail their objections to the EPA and at the same time requested an oral hearing. When an oral hearing was granted they were delighted. Here at last was some hope of stopping the incinerafor. In reality, the hearing was a sham. Despite the complexity of the evidence being presented, ranging from foetal toxicology to clean production, the hearing was overseen by a single man (an engineer) with a pile of A4 pads and a pen. He was to chair the hearing, listen, absorb and understand the evidence, take notes on it (no electronic recording was allowed) and then go off and write a

report, drawing on his engineering background. Disheartened by the inadequacy of the hearing, the community battled on, with the support of Greenpeace, the Clare Green Party, Cork Environmental Alliance, Askeaton Animal Health Group, and a host of expert witnesses from the UK, USA and Belgium and Canada. According to Dr Vivien Howard, who was amongst CAAI's witnesses, incineration is not a method of destroying toxic waste, but simply a method of changing the chemical nature of the waste and then dispersing it into the environment.

Of the five thousand chemicals estimated in the gasses emitted from incinerators, the toxicology of only a few is known. Those that are known include Dioxins, perhaps the most toxic group of chemicals ever produced by humans. They are linked to a range of cancers, developmental problems, disruption of the immune system, and most recently they have been shown to be hormone disruption. They are fat soluble, and thus bioaccumulate and biomagnify in the food chain. What is perhaps most worrying about Dioxins is that they seem to exert negative effects even at the most infinitesimally low levels.

The EPA chose to deny every piece of evidence put before them by the CAAI, Greenpeace and the Clare Greens. Chairperson Kieran O'Brien said in his report that he did "not consider that new evidence of the toxicity of dioxins has been presented....that would justify serious concerns regarding the emmissions of dioxins as provided for" in the EPA licence. It seems that Mr O'Brien was paying more attention to Prof C. Rappe, the expert witness for Roche. Incidentally, Prof Rappe recently completed research for the EPA on Dioxin levels in Ireland. He flew all the way over from Sweden in order to hand out copies of his four page CV. Unfortunately, his written evidence as submitted, was hardly longer than a CV and only contained a couple of references. It seems the people of Clare are not worthy of the same. academic rigour that Prof Rappe would presumably employ when consulting to international institutes, such as the World Health Organisation. So the EPA went for the easy option. They did not insist that Roche do a thorough audit of every toxic chemical that comes into its Clarecastle factory, what quantities of it goes into their products, and what amounts end up in the air, soil and water. Such an audit is an essential precursor to responsible waste management. They did not insist that Roche immediately set targets for ending the use of their most dangerous chemicals. They did not insist that Roche take up an offer by Ecologic, a pioneering waste disposal company, to test a sample of

their waste. A true indictment of both Roche and the EPA is that a local member of the public was the one who contacted this company and who recieved the offer of testing Roche's waste. Instead the EPA sanctioned Roche to spend £12 million on an incinerator, which although it may reduce air emmissions, will emit unknown and toxic chemicals into the air, will greatly increase amount of contaminated water being discharged into the Fergus estuary and will produce toxic ash. The incentive to detoxify their manufacturing process is removed for another while, as the incinerator can now "solve" the problem of toxic waste. I consider that this oral hearing showed clearly that the EPA is little more than an Industrial Protection Agency. At present, toxic waste incineration, is legal and the EPA seems determined to ignore new evidence about the dangers of Dioxins. Given that there are thousands of other chemicals produced by incinerators, the dangers of which have never been tested, licensing of incinerators is also a blatant denial of the precautionary principle - If you don't know what these chemicals do,

don't make them. So with a planning process that will not consider the environment nor human health, and an EPA that conducts sham oral hearings, is there hope

for environmental justice in Ireland? I believe there is because in many places, people like those in the CAAI are saying NO and will continue to say NO TO TOXIC WASTE

### And from Earth First! Action Update

#### (Jan '97):IRISH DIGEST

When he heard the news, he got paint and cloth out and composed the banner. The message done he got in his car and drove into Limerick city and onto the Ennis Road in County Clare. Less than an hour after leaving his farm in East Limerick the man, whose herd of cows had been killed by toxic pollution, was stood outside the gates of Syntex's chemical factory in Clarecastle with a banner letting everyone who cared to know what he thought about the Irish **Environmental Protection Agency.** "How can you licence these people when you don't even know what killed my cattle?" "I was overwhelmed", said one person who has been fighting Syntex's plans to build a toxic waste incinerator for the best part of a year, "that a sixty year old man whose livelihood had been destroyed can do something like this. We got up there to join him along with a rake of children". That morning the EPA had turned down the community's appeal aginst the incinerator, effectively dismissing their fears about the health effects from toxic pollution. "We're being poisoned and the state doesn't care".

### Limerick Dump on Sacred Site

Limerick Co Council are planning a major landfill dump near Glenstal Abbey, and locals and monks are not too happy.

t is to be sited on Sliabh Phelim, an ancient religious site and it will leak leachate into the River Mulkere, a fine salmon river and a potential drinking water source for Limerick City.

rother Anthony is at the forefront of the campaign. He is bitterly critical of the role of the "environmental experts" in the case, MC O'Sullivan, who provided the Environmental Impact Study (EIS). "They tell lies," he says bluntly. One example is when they were making a presentation on the site, a key piece of information was deliberately distorted. It was a map of water sources (acquifiers), and the status of the dump

location was changed from "an area of extreme vulnerability" to "an area of low vulnerability."

hen the Brother pointed this mistake out to the company principal, BP O'Halloran; "He said nothing in reply, he just blushed and scowled and said absolutely nothing. "O'Halloran is on record as saying: "I would not employ a hydrogeologist unless I was sure that they would give me the right answer."


he dump location is currently owned by Coillte, the state forestry company which recently held "National Tree Week". Coillte plan to sell the land to the County Council. Brother Anthony points out that Coillte are in breach of their legal obligation to have "due regard for the environmental and

amenity consequences" of their activities. (1988 Forestry Act, Section 13, subsection 1).

ocal FF politicians are verbally opposing the plan. FG politicians are more wary: their supporters are concentrated in the Limerick suburbs, who are glad the dump won't be in their area.

he protestors plan to hold a
Tribunal of Inquiry, in advance of
the pollution disaster that is the
dump. "We're inviting the Ministers for
Health and Agriculture to attend or to
be legally represented, or be impersonated by an actor. We're still working on
it," says Brother Anthony.

UGAR WITH A HEALTH WARNING? - "This sugar was made using genetically modified sugar beet. The long term effects of eating this are unknown, but it may contain allergens and toxins not found naturally in sugar."

In January, due to U.S. pressure, the European Parliament decided to allow Genetically Engineered (G.E.) food to be sold without labelling. The only way to know if your food has G.E. ingredients is to ask the European Commission if it's on their register. Now Monsanto plc. have been granted a licence to plant G.E. sugar beet in Ireland.

enetic engineering involves the transfer of hereditary material (DNA or RNA) from one or more organisms to another organism, in a way which cannot be achieved by natural methods of mating or cross-breeding. Proponents of genetic engineering argue that this is merely a continuation of work done by humans for thousands of years to improve crops and livestock, by crossing for example, similar plants and replanting the seeds of the best offspring. But the technology of recombinant DNA allows humans to cross the lines nature draws. The new science allows people to introduce genetic material from a cat into a dog to get a hybrid, or human genes into pigs, animal cells into plants and resistant genes into non-resistant genes. Genes from a fish have been spliced to the DNA of a tomato to produce a new tomato with delayed ripening. The proposed C.E. sugar beet crop for Ireland has been doctored with genes from a bacteria, a virus and a flower, rendering it immune to Monsanto's own herbicide, Roundup.

o-one can accurately predict the outcome of this genetic tampering. Genetic structures have evolved over many millenia, the repercussions of suddenly altering these cannot be predicted. 37 people died and 1,500 were disabled in the U.S. in 1989 as a result of consuming a genetically modified health food, Tryptophan, which contained a previously unknown toxin.

onsanto plc. has developed a genetically engineered soya bean also tolerant to Roundup. Soya is contained in 60% of all processed food. They don't have to tell you if their "Roundup Ready Soya" is present or not. On 29 November last, following an investigation by the Consumer Frauds and Environmental Protection Bureaus, the New York State Attorney General forced Monsanto to withdraw T.V. advertising which claimed that Roundup is "safer than table salt" and "practically non-toxic". The ads stated that Roundup biodegraded "soon after application." The N.Y. Attorney General said: "Claims that pesticides are as safe or safer than table salt are misleading - period." Similar versions of this advertisment have been shown recently on RTE.

### Legal challenge to Genetic Sugar Beet Trials

n Tuesday May 13 1997, Judge Michael Moriarty in the High Court granted an interim injunction to Ms. Clare Watson, a founder member of Genetic Concern!, preventing the Monsanto multi-national chemical company from planting genetically engineered sugar beet in Carlow. The injunction has been granted pending a judicial review of the EPA's decision to grant Monsanto a licence for Ireland's first ever field test of genetically engineered plants.

he EPA's decision has received much criticism both from the public, and from political parties, including Fianna Fail, Progressive Democrats, the Green Party and the Natural Law Party. "Most Irish people have no idea what genetic engineering is, much less know that the government are allowing multinational companies perform experiments here" said Quentin Gargan, spokesperson for Genetic Concern!. "This whole issue has been sprung upon Irish citizens with no opportunity for public discussion, and a point blank refusal by the Government to allow a Dail debate. The public had only three weeks in which to inform themselves of the risks involved and to make submissions to the EPA. We have to learn from our experience with BSE that science is entitled to change the safety status of any process as new information comes to hand." The injunction has since been lifted and the judicial review is expected in late July. Genetically Engineered Sugar Beet was planted in Carlow within 10 minutes of the Courts decision to lift the injunction.

ne individual in the Irish horticultural profession I spoke with had this to say about Roundup: "There were two of us working downwind from the orchard where Roundup was being sprayed to kill weeds, for the following few days we both had flu like symptoms. It was the only time that just two of the 60 people working got a flu and it didn't spread. I do believe it was Roundup poisoning and not the flu."

resistant oilseed rape/canola, corn, cotton, potato and sugar beet. One of the biggest fears of genetically engineered crops is that mutated genetic material may escape into other plants. Once released into the environment, these stray genes are impossible to recall. Research in Denmark saw that genetically engineered resistance to a herbicide in oil-seed rape was transferred to weeds which then passed it on to the next generation. While German trials of a G.E. sugar beet crop similar to the one Monsanto intend to plant here found that the new genetic material spread to weeds easily Austria has banned all releases of G.E. organisms.

onsanto applied to the Environmental Protection
Agency (EPA) on 16 December '96 for permission to
conduct planting trials in counties Cork, Kilkenny and
Carlow. From the company's point of view it provides farmers
with effective weed control, as the entire genetically engineered sugar beet crop is tolerant to having Roundup
sprayed on it. Monsanto's patent on Roundup is going to run
out in a few years, putting the company under considerable
economic pressure to step up production.

n mid April Monsanto withdrew their application for field trials in Cork and Kilkenny. Tom McLoughlin of the EPA confirmed that the applications were withdrawn and refused to comment on whether it was the concerns of locals in the trial growing areas that forced their decision. He did say that Monsanto wanted to keep the names of the farmers and the growing sites secret. Such secrecy is unacceptable under EPA guidelines. On May 1st the EPA granted a licence to Monsanto to grow the genetically engineered sugar beet at Oakpark, the Teagasc research farm in Co. Carlow.

pressure group called Genetic Concern! has formed to highlight the issues involved with genetically engineered food. They have had a number of public protests in Dublin in recent months. At one demonstration, a large banner was draped across the railway bridge at the Customs House saying: "You said these were safe! - Chernobyl, DDT's, Dioxins." Two of the group were arrested for trespass and had to pay £30 each to the poorbox.

he group say that "The first purposeful release of genetically modified organisms into the environment cannot be made until there has been a thorough debate on the ethics, safety and usefulness of this technology. To date there has been no such debate."

n April 22 Genetic Concern! delivered a letter to the Minister for the Environment and held a demonstration outside the Dail where "Sucker", the 3m high Roundupswigging Sugar Beet and numerous giant green leaves with skulls heads were in attendance. The letter to the minister called for a task force initiative to be established between the Dept. of the Environment, the Dept. of Agriculture, Food and Forestry and the Dept. of Health to examine the ethical and environmental effects of Genetically Modified Organisms. Monsanto have cited protection of the farmers anonymity and what they saw as a threat of the sites being interfered with, as reasons for their application withdrawal. Quentin Gargan of Genetic Concern! said at the demonstration on the 22nd that they knew the names of the farmers involved and the location of the test sites and that the most likely reason for Monsanto's

withdrawal was the rising concerns of the locals in the areas which would have been affected. The Cork Environmental Alliance is also opposed to the planting trials. A spokesman said that "Food producers, retailers and consumers must call on the Government for a moratorium on the deliberate release of genetically modified organisms in advance of any decision of the Environmental Protection Agency."

ugar is in almost all foods, this issue affects us all. Changing the gene structure of our food is of monumental importance to us and future generations. Do we want to eat this food? Are we satisfied that using extra herbicides is the best way forward for agriculture? What do we do with superweeds? Can we afford to leave it up to the EPA to decide whether or not it is good to grow man made genetically engineered sugar beet in this country? This will be the first time such crops have been considered for planting in Ireland. Is it too much to demand a full open public debate on the issue and demand that we be told whetherour food is genetically engineered or not? I don't think so.



### IRELANDand

n a recent response to a Dail question, Tanaiste Dick Spring recently proclaimed that Ireland is "a small country with no armaments industry and no military obligations towards other countries". In spite of two recent reports presenting evidence to the contrary the Government still covets the sacred cow of neutrality and claims that our hands are clean when it comes to the arms trade.


more circumspect response from Enda Kenny (Minister for Tourism and Trade) does hint at the real level of acceptance within government that the arms trade is here to stay: "It must be stated that, in layman's terms, Ireland is not a producer of arms...However, it is inevitable that in an economy such as ours with its high technology base, there will be goods manufactured and exported which have both military and civilian applications and even a small number that have purely military application." Implicit in the above statement is the assumption that, for most of us mere 'laymen' we are happy enough to believe the myth and too ignorant to see beyond it. Also implicit is the fact that we are involved to an extent in the arms trade, but that the level and type of involvement is far too complex for 'laymen' to understand and therefore it doesn't really count.

we can make up our own minds as to the extent and nature of our links to the arms trade: In July last Action From Ireland (AfrI) published the results of its year-long investigation into these matters, "Links: Ireland's Links with the Arms Trade." Its findings revealed a number of companies that are, to varying degrees, contributing to the trade in

arms. What this means exactly is that:

1. Their products are ending up with a military end-user and, 2. they are intended for a military end-use. In fact these are two of the criteria used by the Stockholm International Peace Research Institute (SIPRI), (generally regarded as the world authority on monitoring the trade in conventional weapons) to identify the trade in weapons technology.

hat AfrI found was that Irish companies were exporting aerospace and microelectronics technology for military use. One company, Data Device Corporation (DDC) in Cork admitted that 65% of their microelectronic products found their way to military aircraft. Another firm, Moog of Cork, supplies electronic control equipment for the elevation and traverse of artillery guns, or in other words, part of the aiming device.



Weapons of War firm in Clare supplies about a quarter of their radar technology to military airforces. All the other firms named either service or supply the military sector abroad. The report was greeted with derision in some quarters, such as the Independent newspaper, and was wel-

comed by others, yet still regarded as somewhat tenuous evidence of our increasing involvement with the military industry. Joan Burton, Minister for Trade, called it "baseless and naive", indicating again the patronising attitude that politicians often display toward "laymen".

ne of the principal counter arguments against the report's findings was that the exported products involved were 'dual-use', thereby being mainly innocuous and impossible to prevent going to the military. The term "dualuse" is, however, a smokescreen used by governments and advocates of the military industry to conceal a hidden part of the arms trade. As "dual-use" goods are governed by European regulations a supplier is obliged to know who the end-user is and what end-use their products will be put to, as these details are required by the licensing authorities for exports outside of the EU. Moreover, any products destined for a military end use have to conform to certain standards and are tested and manufactured to higher specifications than civil goods. This is why they usually cost a lot more. Put quite simply, a company is aware if its exports are intended for military related purposes and, therefore, can choose whether or not to supply 'dual-use' goods to a military end-user.

n the wake of the Links revelations more information was forthcoming which indicated that the authorities were playing a bigger role in all of this than we were aware of. It became apparent that not only were "dual-use" goods being licensed for export to the military, but that "military" goods were also being licensed for export.

### the Arms Trade!

Report by John Cullen of Action from Ireland

Distinct from "dual-use" goods, "military" goods exports come under national controls and are subject to the discretion of national licensing authorities.



Ireland has exported military goods to Turkey, Columbia and Brazil

ased on the new information, we did a follow-up to Links which focussed more on the licensing and on two specific companies in particular. What we found was startling. The Department of Tourism, which is responsible for licensing of exports, had issued 34 licenses (one licence covers one consignment) for export of military goods up to October of last year. This was three times the estimate – a dozen – given by Joan Burton in a "Questions and Answers" special hosted by AFrI in the Mansion House.

the destinations for which these military goods were receiving licenses: Turkey, Colombia and Brazil were the three most disturbing. Didn't the authorities know about the gross human rights violations in these countries? All this information is publicly available from groups such as

Amnesty International and yet the Department of Tourism and Trade, with approval from Foreign Affairs, were allowing military goods to be sold to these places.

t would appear that the Government is operating a twintrack policy when it comes to human rights and the arms trade. The recent White Paper unequivocally links our foreign policy with human rights records. Furthermore, there is an agreement between EU countries on guidelines for military exports: Human rights, internal conflict and the preservation of regional peace and stability are cited as important factors to consider in military exports. By exporting military goods to the above-named countries, the Government is at least breaching the spirit, if not the exact letter of even the minimal efforts made to control the arms trade.

oog of Cork helped to develop A an improvised version of the Bofors L-70 air defence gun for Singapore. However, it seemed to miss the attention of our vigilant authorities that Singapore was a well known conduit for arms diversions to third countries and has been at the centre of a number of international scandals regarding arms shipments to embargoed countries. It transpires that the gun which Moog helped to develop will eventually be sold to the South East Asian market. The most likely recipient for the upgraded version, according to SIPRI, is Indonesia. And we all know of the role of the Indonesian military in perpetrating genocide in places such as East Timor and West Papua.

n the supplement to the Links report we attempted to suggest ways in which our involvement in the arms trade could be halted. We highlighted how there is a clause within the European "dual-use" regulation that allows the authorities here to prohibit the export of certain goods that are clearly intended for a military end use, as "to allow such exports to proceed is contrary to the fulfillment of our international obligations."(Article 10 of the EU dual-use regulation).

oreover, as military goods are subject only to national controls, there exists even more scope to abolish completely this trade.

o put it in "Layman's" terms, modern weapons systems rely on the input of nuts and bolts, microchips, wiring etc...the microdesign may differ, but the macro design serves the same purpose - to maim, kill and destroy.

Write to the Minister for Tourism and Trade, the Minister for Foreign Affairs, and demand an end to Ireland's involvement in the arms trade.

y biggest surprise so far in 1997 was to read in an edition of Connections (a magazine devoted to tracking international progress in implementing Agenda 21), that all Irish local authorities had initiated Local Agenda 21.

This was news indeed, given that the experience of various local community groups and non-governmental organisations had been somewhat different. A survey of local authorities carried out by the Irish Womens' Environmental Network indicated that only a handful were seriously planning their implementation of this chapter of the UN agreement on sustainable development. And in the case of one Dublin authority, its interpretation of 'sustainable development' seemed to be limited to expanding public parks.

conflicting signals form the Department of the Environment. Brendan Howlin's now infamous publication last December (where he abolished water charges) called A Program For Change was a plan for reform of local government to make local authorities more efficient and responsive to their local communities. The aim was to use the Strategic Management Initiative to revitalise local government from within, and to harness local expertise and viewpoints from without to enabale non-elected representatives to have input into local policy making.

o date, there seems to have been a lukewarm response by local authorites, including local politicians, to this initiative. From the point of view of those of us trying to promote Local Agenda 21, the Programme for Change initiative was a wasted opportunity to spell out principles and policies in order to make local government more democratic and more sustainable. Local Agenda 21 barely featured in the document and as such, the Department of the Environment has explicitly fostered the impression that sustainability is something extra local authority must do something in addition to, rather than as an intrinsic part of local government reform. The government's proposals for local government reform then take no account of the potential role of local authorities in facilitating cross-sectoral dialogue and building equitable and healthy local communities. And more importantly, it contains no vision, no sense in which local democracy is potentially a political space, shared equitably, and whose overall purpose is sus-

t is improtant to note that Local Agenda 21 has been a huge success in England precisely because it has been driven by politics. In Labour and Lib-Dem councils in particular, elected memebers were frustrated by the way in which successive Tory Governments had repeatedly undermined local government. They argued that they had a more legitimate mandate to act on behalf of, and in the interest of local communities. As a result, local sustainability initiatives in the UK have tended to be effective exercises in community participation in local decisionmaking, but often with the aim of providing a political alternative to national government.

ocal politics in Ireland is hopelessly conservative, clientelist, and occasionally even corrupt. It is unlikely, given the predominance of a 'parish-pump' political culture, that our local politicians will embrace enthusiastically the principle of public participation. Many of them, especially Fianna Fail and Fine Gael councillors, have been supportive of precisely those policies which have negative environmental and social consequences - rezoning being the most obvious example. Yet there is also a democratic deficit at local level that cannot be ignored, whereby the bureaucracy has more clout than elected members. This only encourages abuse rather than encouraging responsible and progressive local government.

here is however an alternative - community-led local Agenda 21. Our project in Dublin City (that is within the functional area of Dublin Corporation) is to create a platform of community based organisations to promote sustainable development at a local level. We argue that grassroots activity must be seen as central, rather than peripheral to, the implementation of Local Agenda 21. The participation of communites which are socially excluded is an utmost priority, especially given the fact that the poorer in our society suffer environmental negative (such as traffic pollution, community severance and lower quality of life) to a much greater extent. In this context, Local Agenda 21 offers a way around the traditional perception that environmental politics is only for the better off.

o date we have organised meetings in various parts of the country to promote Local Agenda 21 amongst the community sector. Our current task is the organisation of the community platform for sustainability as mentioned above, with a view to making any future community representation on Dublin Corporation's policy task forces accountable and representative. Furthermore we believe that a 'big push' from the community sector will create the political impetus necessary to get the Corporation to adopt more inclusive policies. But the local authorities are not the only bodies which need to be engaged in local sustainability initiatives - the area-based partnerships, the regional authorities and other agencies need to accept the principle of participation rather than consultation in their activities

s far as sustainable development itself goes, there is a need to spell out how environmental sustainability can converge with social objectives. One example of how this might be done is by tackling fuel poverty. Investment in energy conservation measures creates jobs, saves money for those who have less of it and improves the quality of life of the poor. A project in France to improve the energy efficiancy of schools whereby the schools can "recycle" the money saved is another example of how sustainability can make a real difference when people have inputs into the decision-making process.

he prospects for Local Agenda 21 in Ireland are, despite the picture presented by the local authorities themselves, quite good, if it is seen to be consistent with community based participation, education and training initiatives in disadvantaged areas. But as long as it is viewed as yet another project or task, rather than a way of doing things, it is likely to go down in Ireland like a lead balloon. by Sadhbh O Neill

website produced in County Mayo have recently published a report on the quality of Ireland's drinking water supplies. Taking their information from an EPA report and other sources, the results are frightening. This is what they found: All of Ireland's Group Water Schemes and 50% of state run drinking water have been or are bacteriologically contaminated by E.coli and other yet undetermined bacteriological contaminants. Bacteriological pollution is frequently an indication of intensive agriculture or improper planning, siting of domestic dwellings and septic tanks.

Coli is the nasty bacteria which caused all those deaths in Scotland a few months back. The Environmental Protection Agency 95' most recent reports (1993 to 1995) show that the whole country has a Big problem and Not just the rural Group Water Schemes.

he 1995 EPA report "The Quality of Drinking Water in Ireland" has been published - in December 1996, seven months later than usual. There are ommissions in many EPA reports, including the results from some of Ireland's most contaminated supplies. The 1995 report is particularly incomplete. Some County Councils are not providing results to the EPA. County Mayo is the worst offender having failed to provide the vast majority of its water test results to the EPA. Icarus Ireland is currently investigating why the EPA results appear to have been 'doctored' by some County Councils. Despite this doctoring, the overall summary (when corrected to accommodate the government's omissions) indicates a steady increase in drinking water contamination throughout the country in the three years up to January 1st 1996.

here are two measurements for contamination: Total Coliforms and Faecal Coliforms. The EU and WHO standards for acceptable levels for both of these parameters is NIL (zero). Faecal Coliforms (E.coli) prove recent contamination by animal or human faeces and indicate a high risk that other possibly deadly biological contaminants such as streptococci or parasitic organisms will be present. Even the most illegal and severe E.Coli contaminations are classified by the EPA as "generally satisfactory". The EPA is underresourced and unable to fulfill its statutory function.

### Highlights of the Icarus report

95.6 % of County Council and other Water Authorities in Ireland experienced contamination by E.coli, 100% of Group Water Schemes in Ireland are or have been affected by bacteriological contamination (Coliform or E.coli indications)

coli contamination for both

Group Water Schemes and Local
authority Water supplies range in
severity from 1 coliform / 100ml to
100,000 coliforms/100ml, Almost every
single County Council in Ireland
(including 50 sanitary authorities)
had incidents of contamination of
their drinking water supplies by coliforms including E.coli during 1993,
1994 and 1995. (Ref. Table Al.3, page
34 of the referenced EPA reports).

There were 4582 tests showing illegal levels of bacteriological contamination. This contamination occurred in 47 out of the 50 participating local authorities (not including Group Water Schemes).

uring the 3 year period, all group Water Schemes showed contamination, indicated by Coliform/E.Coli counts over EU and WHO limits. 585 Group Water Schemes were examined in 19 counties. Some 3265 water samples were tested for E.coli, of which 1455 samples showed coliform (total and E.Coli) contamination in excess of the limits (zero). (Ref. Table At. 3, page 34 of the referenced EPA reports:). Most incidents of contamination of Group Water Schemes had levels of contamination between 20 and 500 coliforms /100ml. 78% of all contamination incidents were contamination by more than 20 coliforms /100 mls. There were 1129 water tests producing these results from 1455 contaminated samples. (Ref. Table A1.3, page 34 of the referenced EPA reports).

ublic supply contamination incidence is generally lower than
Group Water Scheme contamination because of extreme use of disinfection techniques. However, EU and WHO legal limits for chlorine, fluorine and aluminium in public supplies are being exceeded.

### Lucan community vote against development

People living in Lucan are celebrating victory over the developers: a mini referendum saw 2,500 people turn out to vote against a massive new development.

Shannon Developments wants to build 350 houses on 35 acres of green land in the Liffey Valley. Residents point out that since 1991 3,900 houses were built in Lucan, and that the land being built on is the greenbelt separating Lucan from Clonsilla. "When the planning permission went before the council, Lucan Community Council held a meeting. and it was decided to hold a referendum of people in the area. We had the backing of 21 residents' associations and each one volunteered to drop leaflets in their own areas," says Ann Graham, chair of the community council. "We held a press reception on the bridge, and stood where the road was, handed out leaflets, made people aware of what was happening. We had three venues for polling, we had voting cards and we crossed names off the electoral register. Some residents weren't on the register, but they were genuinely residents, so we let them vote." The result was 97.4 percent against the development. Of 2,500 votes, only 63 were in favour. The total electoral register

of Lucan is 13,000, but many are in newly formed housing estates. Since 1991, 488 acres have been built on and another 1900 houses are on stream.

Ironically, in other parts of the valley, the state is buying up land to create a Liffey Valley national park, while the state has given the go ahead here to destroy it. The rezoning was controversial in 1993. when it was one of the last acts of Dublin County Council before it was split up. It passed by only one vote. Dessie O'Malley promised residents that the PDs would oppose it, but it was Sheila Terry of the PDs who actually proposed the motion. O'Malley apologised afterwards, but as Graham noted, it was after the fact. 3,000 signatures were gathered locally to oppose it. The original proposal was to have 4 houses to the acre, but after it was pointed out that some of this land should stay greenbelt, it was changed to 10 houses an acre. And of course, should a future council decision rezone that land in the future. there would be room for another few hundred desperately needed houses. An above ground reservoir is planned, and there is an application for a road right through a cliff face, overlooking listed houses. It will create a cross roads at the bridge over the Liffey.

Initially, the development was turned down

on the grounds that the sewerage was inadequate. Then the county manager for Fingal, prepared a plan telling the developers what was needed to get permission.

Adding to the difficulty of the residents is that they are in the South County Dublin area, but the development is just across the border in Fingal County Council, making it impossible to put pressure on the Fingal Councillors responsible for the rezoning. But Graham notes that the three local Lucan councillors were not supportive. They are: Peter Brady (FG), John O'Halloran (Ind), Finbarr Hanrahan (FF). FF TD Liam Lawlor was seen as very vocal on getting the special area order for the Liffey Valley in place. Building on the success of the referendum, the local community are making objections to Fingal County Council. They are looking for a meeting with the Minister for the Environment and have written to all the leaders of the political parties. Dublin Corporation has not given the go ahead for a sewerage link up so the development may have to be abandoned on technical grounds.

### Cement Factory Outrage

Residents in Mayo are outraged over a proposed cement factory, which will increase total Irish output of CO2 pollution by as much as 1.5 percent.

CO2 causes global climate change and international agreements and the EU require Ireland to undertake urgent reductions (not increases) in CO2 emissions.

The plant, sited near the Knock Marian Shrine, will also pump out tonnes of sulphur dioxide every day — this is the gas that produces acid rain. That's not to mention carcinogenic dust. The plant will operate 24 hours a day, seven days a week, and will require constant arrival and departure of

heavy lorries in a densely populated rural area. The plant will cost about £50 million and will have a turnover of roughly £50 million a year. The developer is a local businessman called Harrington. Frank was the main contractor for Knock Airport, and he also supplied the concrete for the Basilica at Knock. which is mostly made out of concrete. Locals at first welcomed the plan: 200 jobs were promised in a press release by lim Higgins. But as the people started looking into it, they found that in the official Environmental Impact Study (EIS), Harrington mentioned only 104 jobs. Many of them will be specialised - A German firm is undertaking construction. And because the plant will be very highly

automated, it will be producing cement cheaper than existing CRH plants elsewhere, leading to certain job losses. An opinion poll done by campaigners showed that half of local people thought there would be less than 50 jobs at the plant.

The site is just over a mile from Knock airport: A 270 foot chimney so near an airport must be a problem, and the Department of Transport is looking into it. The residents are meeting Mayo County Councillors and hope the councillors will use their powers to stop the planning go ahead. A public meeting is planned.

They continue to consult with all the communities about the direction of the negotiations they entered with the Government. Their commitment to equality of human beings is also striking. Unlike most guerrilla armies they do not want to seize power and form a "provisional"

government." Instead they are to open a space for "civil society"-- for the citizens at large, in groups big and small- to change the shape of Mexican society. In the long run to change the World. For Humanity.

apatistas take you all the way. A Revolutionary movement at the end of the 20th Century....It's not all road protests and vegetarianism. Saving the World takes different forms in different places. In Mexico, the Zapatistas- new age revolutionaries armed and media friendly, are ready to take on the whole world of injustices and include you in the process.



first it all seemed familiar- a band of armed and masked rebels rise up and spectacularly take control of some towns in one of the more wretched corners of our world. Chiapas in Southern Mexico, the poorest of the poor, populated by indigenous people, 500 years of dispossession, ignorance, misery, oppression. So they came down from the mountains, the forever dead, toting AK47's and insolence, to declare 'Basta Ya!' (Enough is enough), here we are, a government nightmare, off our knees.

he Zapatistas were a mere 10,000 strong army (E.Z.L.N.) and a support base of a few hundred thousand within the indigenous communities of Chiapas. Over the three years they have applied the idea: ACT LOCALLY, THINK GLOBALLY with impressive results. The Zapatista demands for Justice and Freedom for the indigenous of Chiapas has become a global call against the general economic system that affect us all. They defined it as Neo-Liberalism, the Capitalist model of development: profits before people, competition before co-operation. By breaking their own chains of oppression, the Zapatista were making links with struggles in other places.

hree years later, against all odds, Asterix and Co. of Southern Mexico are proving indomitable and refreshingly imaginative. Their magic potion?

People's power - civil society and grassroots support. A little bit of magic and a lot of vision and organising!

gainst the might of the Mexican Army they pitted the strength of a million Mexicans who took to the streets to demand STOP THE MASSACRE!!

Against the dictatorship that is the Mexican

Government, they pitted Truth and Justice. Having fought to a negotiating table with the Government, they assembled a strong team of dissenting voices from all sectors of Mexican society -alongside the masked rebels- to expose the lies, deceit, and non-sense that marks Mexican political life.





Creating an international of hope

cally, the Zapatistas occupied lands owned by wealthy landlords and took control of municipalities, driving out the corrupt government incumbents. They released their desire for TIERRA Y LIBERTAD, Land and Freedom, and defended the gains of the uprising with arms. Nationally, they brought people together under a civil society based Zapatista Front. Here the energy of the millions who had marched or spoke out in their name could organise. They held a national plebiscite to ask the people did they support the Zapatista demands and a resounding 1.3 million responded YES.... Meanwhile they held an indigenous convention where representatives from Mexico's 44 Indian tribes came together to demand Autonomy. Internationally, they made extensive use of the media and the internet to make links with people all over the World. From the mountains of the Mexican southeast came the call to an intercontinental Encounter for Humanity and against Neo-Liberalism. The encounter took place last Summer in five small villages in the mountainous jungle of Chiapas hosted by the Zapatistas. Four thousand people from 43 countries (including half a dozen from treland) gathered for five days to discuss how people are resisting Neo-Liberalism across the planet. "Liberalisation of the Market" for Big Business means axing the Welfare State and breaking down workers' organisations by making strikes, etc illegal. A big plank in the Neo-Liberal programme is the globalisation of the market-place; allowing multi-nationals to take what they want, sell their products or dump their waste any where they choose. All over the world the progress of Neo-Liberalism has meant an increase in unemployment, a fall in standards of living and loss of civil liberties.

he thread running through the Encounter was a shared belief. All of us who believe in Humanity, who think that people matter more than profits, must build as wide an alliance as possible to defeat the many-headed monster that is Neo-liberalism. Out of the encounter came the plan to build a global network of struggle, an International of Hope to resist the international of despair - Neo-Liberalism the economic and social policies pioneered by people like Maggie Thatcher and Ronnie Reagan. In Ireland this project was taken up by the Irish Mexico Group, two of whom were at the encounter.

ow is perhaps the time for change. This year a second intercontinental Encounter will take place, in the Summer at various places in the Spanish state. A European Continental Encounter took place in Prague in March, to act as a kind of first stage on the way. Preparation has already started and the organisers are asking people to start making plans to come to the Encounter to represent whatever struggles they are involved in, and to listen!! The Encounter does not aim to set up, a new wonder party with all solution to the world's problems. If it takes off as the first Encounter did, it will be an Energy-and-Hope-giving meeting of the peoples of the world, and another step towards building that global network for survival. As Subcommandante Marcos said: 'It is not necessary to conquer the world. It is enough just to recreate it ourselves. Today."

### Fyffes Treatment Of Banana Workers

in December and reported on the continued ill treatment of banana workers in plantations owned by Irish multinational Fyffes. Workers who are suspected of being union members are sacked and busloads of raw immigrants are brought in to replace them. Some sacked workers don't get their full pay back. As reported by RTE's Divided Worlds, women have to arrive at work early and wait, sometimes for several hours, until the bananas arrive from the fields. They are not paid for this waiting time. Company reps are harassing the union leader, Maria Funes, continually calling at her house, houses of friends and even her daughter's boyfriend's house. A Fyffes executive in Belize said that if Funes insisted on criticising Fyffes abroad and in Belize, then they had a "right" to follow her.

but for a six day week at 12 hours a day, they receive the princely sum of \$80. They get a total of 55 minutes break each day - when they asked for another 10 minutes, they were told they could always leave if they didn't like the conditions.

### Fairly Traded Coffee From South America and Africa

Two brands of coffee are now available in Ireland which are fairly traded. They carry the "Fairtrade Mark", which is an independent guarantee to the consumer that third world producers have been paid a fairer price, work in safe and decent conditions and with respect for the local environment. One of the brands is "Bewley's Direct", the first fairly traded coffee roasted in Ireland. It comes from small farmers' co-operatives in Central America. It is the first trish brand to carry the "people friendly" Fairtrade Mark. The other brand is "Cafedirect" which comes from small farmers co-operatives in Latin America and Africa, and was the first widely available fairly traded coffee in Britain and Ireland.

Twenty million people in the "third world" depend on coffee for their living. In the four years between 1988-1992 the prices paid to coffee producers fell by 80%. Fairly traded coffee pays producers a guaranteed price, which has been as much as twice the market price. Because fairly traded coffee guarantees a fair price and advance payment to producers however low the world market price falls- it costs slightly more than your usual brand... but not more than a penny a cup extra!

### CIA Drug Smuggling

This February 22, there was a major march in Los Angeles to protest CIA involvement in the crack cocaine epidemic in the 1980's. 4,000 people turned out and the event was reported on a number of major U.S. channels, including CNN.

Rumours have persisted since the 1950's of the CIA turning a blind eye to opium, heroin and cocaine smuggling by their allies and employees. In Burma, Vietnam, Laos, Cambodia in the 1950s to 1970s; many Latin American countries from the 1980s, and in Afghanistan and Pakistan, major heroin/cocaine production came only after the CIA started its aid operations.

The San Jose Mercury News in California did an excellent series last Autumn exposing the involvement of the CIA-backed Contras importing cocaine into the US, where they marketed and sold it and showed locals how to make crack.

Despite many eyewitness reports from ex-CIA employees who are prepared to give evidence that they flew shipments of cocaine into the US, often into military bases to be unloaded, the mainstream media have ignored the story, except to rubbish it. Even Ollie North's diaries include references to drugs being carried on planes that had earlier carried weapons to the Contras. At least four highly experienced ex-DEA agents are prepared to give evidence about the blatant drug corruption in the DEA, CIA and US military. They cite coups in Bolivia and Fujimori's takeover in Peru as being cocaine coups, designed to give the rulers more power over the trade. Since Fujimori's election in the early '90s, cocaine production has risen 40 percent, and Fujimori's personal lawyer (the head of the secret services!) is a guy called Vladimiro Montesinos, who is linked to both narcotic traffickers and the CIA. Several US states have severe drug corruption problems: Arkansas under Bill Clinton had a massive CIA/Contra linked smuggling operation. It also saw the deaths of two boys near a smuggling landing place- who may have seen too much. Six witnesses to these deaths have themselves been killed. Their parents are convinced, not surprisingly, that something very wrong is happening. In Montana, the Governor, Marc Racicot, is implicated in heroin smuggling across the

Canadian border. Inhabitants of one town have signed a petition demanding the immediate investigation of some local deaths widely believed to be linked to the smuggling operation. Perhaps the most chilling story is that of Gene Tatum, Vietnam War veteran and then a CIA agent. He had been transporting cooler boxes full of cocaine around Latin America for some time and was unhappy with the reason Oliver North gave for it: "It's seized from the Sandinistas and it's destined as evidence in the world courts." Tatum approached George Bush, once head of the CIA, and at that time Vice President, at an Embassy cocktail party and told him that the US government was involved in transporting hard drugs. George Bush just grinned at him and walked away. Now whaddya make of that? Website info:http://speach.csun.edu


to the international, government sponsored, S.E.T.I. programme operating in other bands of the electro-magnetic spectrum.

### UNIFIED GLOBAL COSSCIOUSNESS







### Heaven on Earth



### Bealtaine Fires 97

Bealtaine, throughout the world and from ancient times is recognised as a focal time of celebration. It is the beginning of Summer. Beal (Bel or Balor), is the solar-fire deity or Sun God of ancient Irish folklore. Tine or taine translates as fire or "goodly fire". Ceremonies traditionally performed at Bealtaine celebrate strength, cleansing and fertility. It is a night of Love and the bringing of fire back to the Earth after the long cold darkness of Winter.

Over the past four years Bealtaine Fires have again been lit on mountains and hilltops around Ireland. This ancient tradition is being re-awakened by a growing number of individuals who are simply glad of the opportunity to celebrate our Gealic heritage on our native Sacred Places. Eight fires were lit in '94, twenty three were lit in '95, and over fourty fires were lit in '96. Bealtaine fires were traditionally lit on the night of the first full moon in May, (which is usually quite close to the cross-quarter day - half way along the sun's journey from Spring Equinox to Summer Solstice). This year however, we celebrated Bealtaine at the New Moon-6th May. I don't know exactly how many fires were lit this year as yet. I joined about fourty people of varying ages and backgrounds gathered on private land in the Dublin Mountains, overlooking the Big City's dazzling lights. Here we sat around a huge Pine bonfire, sang, played music, made new friends and had the crack. A night to stay up late and contemplate the dawn and the magnificence of life. amping in the open air, travelling the country spreading good news, planting trees, inspiring people sounds like a good life to me. The second tree walk has finished its 500 mile trek through Ireland at the Rainbow Gathering in Cadamstown in the Slieve Bloom mountains. Beginning in Sneem in south Kerry on the 7th of February, the walkers and the animals in their care completed a spiral journey through the west, as far north as Longford, through Kildare and Laois before settling in Offaly.



he project is a beautiful example of practical environmentalism at its best. The money for the trees was earned by a group of people who organised the collection and recycling of beverage cans - keeping the streets clean, reducing the degree



of waste accruing at land fills and generating precious income to facilitate the reforestation of Ireland with native species. Living in harmony with the land as they travel, the multinational band of travellers called into schools on the route to tell the children of the country the value of trees. Imagine being ten years old in a classroom when the teacher suddenly tells you to go down to the hall where you are greeted by a colourful bunch of musicians who are into singing, dancing and some informal but potent teaching about the environment and how individual behaviour affects it. A few songs, a bit of slagging then out into the schoolyard to plant a

few trees. When the children go home after school they tell their families the stories of what happened in school that day and so the message is spread through the communities of the country.

satisfaction of working on the "Trees are Life" tape. Both experiences were rewarding and fulfilling - it's great to witness people walking the talk, living the message, planting seeds of hope in hearts and minds as they secure living roots in mother earth.

and the simplicity of this plan delighted me. I took a bucket of white paint and a four-inch brush and walked down to Fade Street, where I then painted a large white circle around the gap. When I had finished I stood back to admire my work, and I was gratified to observe
