#### STATEMENT ISSUED BY LEADERSHIP OF CIRA

#### The following New Year statement has been issued by the Army Council of the Continuity Irish Republican Army

The leadership of the Continuity Irish Republican Army at this time of the year sends fraternal greetings to all Republican prisoners in who are incarcerated in prisons in Ireland, England and the occupied Six Counties and to all freedom fighters in prison across the world.

Our thoughts are with the prisoners and their families at this time of year and we are mindful of their sacrifice for the age old ideals of Irish Republicanism. They are political prisoners who are in prison because of a political desire for freedom from foreign rule for all of Ireland.

The past year has been a difficult one not only for all Republican prisoners but for the people of Ireland in general who have had to endure the humiliation of reduced living standards to pay for the criminal actions of wealthy bankers and property speculators. The public have seen the narrow interests of capital protected by the politicians. A new approach to politics is now necessary and only the policies of the Republican Movement of a new federal Ireland based on local democracy offer any hope for the future. Therefore it is time for the far seeing EIRE NUA policies of Irish Republicanism to take centre stage and point the way forward for the Irish people.


The past year has been a difficult one for Irish Republicanism with the forces of the Free State, the Northern Assembly and the British Government ranged against the age old right of the Irish people to national self-determination. However we take solace from the lessons of history which teach us that for as long as Britain occupies any part of Ireland, there will be Irish men and women who will embrace the challenge of opposing that presence. And if that presence is armed there it follows the response will be in like kind. The reality is that the British armed forces enforce partition and protect the border and the interests of the British Crown. We are heartened by recent upsurge in résistance to the British presence and their Provisional cheer leaders who have tarnished Republicanism by becoming Crown Ministers. Their attempts to criminalize and demonize true Irish Republicans will fail - the upsurge in actions and operations against the British presence is evidence of that failure.

The CIRA today re-asserts the right of the Irish people to the national aspiration of Irish unity and the attainment of that objective in line with the traditional methods of Irish Republicanism. The British can overnight end this conflict by declaring their intention to withdraw from Ireland. We also warn against a visit by the Queen of England to Ireland while her armed forces continue to enforce partition to the detriment of all the Irish people. Any such visit will be opposed by all and every means at the disposal of true Irish Republicans.

The past year has also seen a group who claim to be Republican but have abandoned any principle of Irish Republicanism after being compromised by the Free State. No amount of lies or half truths can hid the fact that they are irrelevant and do now command the support or respect of any true Republicans. Instead of accepting that the Republican Movement has abandoned them, they engage in a campaign of character assassination and smear tactics. We are giving formal warning that this activity must cease forthwith or else they shall suffer the consequences.

Finally the CIRA pledges an escalation of operations and a more intensive military campaign against the forces of British occupation in the coming year after extensive recruiting, training and the acquisition of new weaponry. We now have the men and material to sustain a military campaign until the national question again tops the political agenda.

### DALTONITES TELL LIES TO HIDE THE TRUTH OF REAL REASONS FOR SPLIT

In what was purported to be a Presidential Address at a one day gathering of the Daltonites, a number untruths, distortions and downright lies were told by Des Dalton that cannot be allowed stand on the public record.

His claim that resignations were because of one man who had been a vice-president failed in his bid for President are not true.

Neither is his lie over the Broad Front. The real reasons are that we were called criminals and we objected to the decision to ban cumann being named after men who died in the struggle for Irish freedom.

Republicans resigned in 2004 as Dalton full well knows because they were described as criminals in Saoirse. In fact he has in his possession a letter detailing in full the conspiracy. If he is man enough and indeed adheres to the principles he so eloquently outlines then let him publish this letter so that everyone may see the rotten core at the heart of his grouping.

Dragging in the Broad Front issue is only a smoke screen – and outlining the outcomes of successive ardfheiseannna a mere red herring – as he well knows the leadership tried to change the constitution to recognize the 26 County State administration simply in the interests of obtaining money but it was defeated at the Extraordinary Ard Fheis – yet he is strangely silent on this outcome. In fact if he and his cronies had any common decency they would have resigned.

Dalton knows the current difficulties in the organization arise out of the rigged Ard Fheis where Ruairi O'Bradaigh seemingly resigned as President and installed Dalton yet the former leader retained three roles within the Movement. His leadership is now discredited, corrupt and increasingly Stalinist as it becomes even more irrelevant to the struggle for Irish freedom. History teaches us that leaderships are compromised, bought off and in the pay of the State. Dalton full well knows that the leadership of the entire Republican Movement has moved on and bypassed him. By telling lies he is reducing himself to the status of a tout!

We do not need Dalton – a man unqualified for the position he holds – to lecture us on our allegiance to the All Ireland Republic of Easter Week. We had no option but to adhere to the democratic wish of the organization and reject his compromised leadership. They declaim like fanatical zealots the moral imprimatur of successive Ard Fheiseanna in relation to policy yet these same people are strangely silent when it comes to the extraordinary Ard Fheis they held behind closed doors to recognize the 26 County Administration so that they could claim money from the Free State.

The current figures leading this witch hunt against us lost that particular round, yet they did not have the sense of democracy nor indeed the principle to resign having being defeated by decent right thinking Republicans who are now the legitimate Republican Movement.

In fact the leader of their diminishing clique, Ruairi O'Bradaigh admitted he had been duped by those around him in holding the almost secret conference, yet he is still in their clutches and by approving lies has reduced himself and damaged his reputation.

One cannot debate with people who are without principle. One cannot engage with people who have no respect for truth and democracy. One cannot take seriously people who have debased every principle of Irish Republicanism.

#### Óglach. Johnny Copeland

Óglach. Johnny Copeland (23) was born in 1949. He attended Holy Cross Boys' Primary School and later St. Gabriel's on the Crumlin Road. After leaving school, John worked as an Upholster before he became a Bus Conductor. Growing up in Ardoyne, Johnny was a keen Sportsman. He fought for the Holy Family Boxing Club, was a Weightlifter, played Soccer and enjoyed Ceili dancing. It was while attending a Ceili that he met Carol and like many Irish people, they moved to England were they both trained to become Nurses.

After completing their studies they returned to their native Ardoyne and were married in 1968. For a time they lived with his Mother, Susan before they bought a lovely home in Ladbrook Drive. Two children, Linda and Eddie soon followed and everything seemed perfect for the Copeland's. However, after the Unionist Pogrom of 1969, many Ardoyne residents like Johnny Copeland volunteered their services to Óglaigh Na hÉireann. When John was not providing for his family, he was to the fore in the defence of his community against British and Loyalist attacks. On October 28th 1971, Vol. Johnny Copeland had just visited his mother and was walking to his home nearby when he was shot in the back by a British soldier. Minutes earlier, British troops shot and killed another Ardoyne resident, Micheal McLamon in Etna Drive. As well as, seriously injuring Eskdale Garden's Mother, Margaret McGrandles who was expecting a baby at the time.


British Crown Forces claimed they had shot gunmen, even though eye-witnesses testified that Johnny, Micheal and Mrs. McGrandles were innocent victims. Mr. McLarnon died instantly, Óglach. Johnny Copeland died two days later. Luckily, Margaret and her unborn child survived the shooting. Like most killings involving British soldiers, no-one was ever prosecuted. Micheal McLamon was rightly declared an innocent victim after a new investigation into his death by the HET a couple of weeks ago. Even though the announcement was decades overdue, it was welcome. In response, the Copeland family told the North Belfast News they had began a campaign and legal proceedings into the murder of their father. Johnny's son, Eddie (who himself survived a murder attempt by a British soldier in1993) told the newspaper that they are seeking a similar investigation. Ardoyne Republican commends the Copeland Clann in their quest for the truth.

# Section 30 - KNOW YOUR RIGHTS!

**OFFENCES AGAINST THE STATE ACT 1939 (SECTION 30): ARREST AND DETENTION OF SUSPECTED PERSONS – LEGAL** TEXT.

## Section 30.—

(1) A member of the Gárda Síochána (if he is not in uniform on production of 'his identification card if demanded) may without warrant stop, search, interrogate, and arrest any person, or do any one or more of those things in respect of any person, whom he suspects of having committed or being about to commit or being or having been concerned in the commission of an offence under any section or subsection of this Act or an offence which is for the time being a scheduled offence for the purposes of Part V of this Act or whom he suspects of carrying a document relating to the commission or intended commission of any such offence as aforesaid or whom he suspects of being in possession of information relating to the commission or intended commission of any such offence as aforesaid.

to be photographed; (d) take, or cause to be taken, the fingerprints of such person.

(6) Every person who shall obstruct or impede the exercise in respect of him by a member of the Gárda Síochána of any of the powers conferred by the next preceding sub-section of this section or shall fail or refuse to give his name and address or shall give, in response to any such demand, a name or an address which is false or misleading shall be guilty of an offence under this section and shall be liable on summary conviction thereof to imprisonment for a term not exceeding six months.

entry and state why he or she is there. If the Garda is refused entry, he or she may break open outer and inner doors to get in.

When a Garda does not have an arrest warrant, he or she may enter and search any premises where he or she, with reasonable cause, suspects you to be.

However, if the premises is a dwelling and he or she does not have the permission of the person who lives in the dwelling, the Garda cannot enter unless :

you are arrested after 5 p.m. you may be brought to the District Court as early as possible before noon the following day. At the District Court, you may be released on bail or remanded in custody by the judge.

Only in certain specific circumstances may you be detained in a Garda Station for a length of time before being brought to court. Under the Criminal Justice Act 1984, you may be detained

(2) Any member of the Gárda Síochána (if he is not in uniform on production of his identification card if demanded) may, for the purpose of the exercise of any of the powers conferred by the next preceding sub-section of this section, stop and search (if necessary by force) any vehicle or any ship, boat, or other vessel which he suspects to contain a person whom he is empowered by the said sub-section to arrest without warrant. (3) Whenever a person is arrested under this section, he may be removed to and detained in custody in a Gárda Síochána station, a prison, or some other convenient place for a period of twenty-four hours from the time of his arrest and may, if an officer of the Gárda Síochána not below the rank of Chief Superintendent so directs, be so detained for a further period of twentyfour hours. (4) A person detained under the next preceding sub-section of this section may, at any time during such detention, be charged before the District Court or a Special Criminal Court with an offence or be released by direction of an officer of the Gárda Síochána, and shall, if not so charged or released, be released at the expiration of the detention authorised by the said subsection. (5) A member of the Gárda Síochána may do all or any of the following things in respect of a person detained under this section, that is to say: (a)demand of such person his name and address; (b) search such person or cause him to be searched; (c) photograph such person or cause him

### **KEY INFORMATION- YOUR RIGHTS:**

An arrest is the apprehending or restraining of a person to bring that person to a District Court within a reasonable time.

You cannot be arrested for the purpose of gathering evidence or 'helping the Gardaí with their enquiries'.

You must be told why you are being arrested, for example, because you are suspected of having stolen goods. However, if you are arrested under Section 30 of the Offences Against the State Act 1939, you do not have to be told exactly why you are being arrested; you need only be told that you are being arrested under that section. If you go voluntarily to a Garda station to assist the Gardaí with their enquiries and are subjected to questioning or interrogation, you must be told and it must be clear to you that you are free to leave the station at any time unless you are arrested.

#### • You live at the dwelling

• The Garda has seen you inside or entering the dwelling or

• The Garda, with reasonable cause, suspects that before he or she can get an arrest warrant, you will either abscond or you will obstruct the course of justice or

• He or she, with reasonable cause, suspects that before he or she can get an arrest warrant, you will commit an offence.

#### **Manner of Arrest**

Force can only be used to make an arrest if it is absolutely necessary. When a Garda arrests you, he or she will actually touch your body or otherwise restrain your liberty. If you are arrested on a criminal charge, you must be informed at the time you are arrested of the charge unless this is very clear (for example, if you are arrested while committing an offence). After you have been charged, the Garda must caution you with the following words: "You are not obliged to say anything unless you wish to do so, but whatever you say will be taken down in writing and may be given in evidence." When you are brought to the Garda station, details of the offence must be set out in a 'charge sheet'. A copy of the details must be given to you. The Garda will formally charge you by reading each charge over to you and you will be cautioned after each charge is read out. The Garda must keep a note SOLICITOR of any reply you make.

#### in a Garda Station for up to 12 hours.

The offence of which you are suspected must be one that may be punished by imprisonment for at least 5 years. The 12 hour period runs from the time of your arrest but you may agree to a rest period between 12 midnight and 8 am and this will not be included in the 12 hours.

In general, if you are arrested you do not have to say anything. However, if you are detained under the Criminal Justice Act 1984 you must tell the Gardaí your name and address. The Gardaí have no general power to take fingerprints or make forensic tests.

They may do these things if you consent or if they have specific power under specific laws, for example, under the Offences Against the State Act or the Criminal Law (Jurisdiction) Act of 1976. Under Section 30 of the Offences Against the State Act you may be detained for up to 48 hours before being brought to Court. If you are detained you must be informed of your right to consult a solicitor.

Often an arrest is on foot of a warrant. However, a warrant is not always necessary.

### **Rules - Arrest without a warrant**

You may be arrested without a warrant when a Garda, with reasonable cause, suspects that an arrestable offence has been committed and that you are guilty of the offence. An 'arrestable offence' is an offence for which the penalty, for a person who has no previous convictions, can be 5 years imprisonment or more.

#### **Immunity from Arrest**

 Ambassadors and their suites and other diplomatic agents who represent foreign governments while living in this country cannot be arrested.

• Members of each House of the Oireachtas cannot be arrested while going to, returning from and within the confines of either House of the Oireachtas, except in the case of treason, felony or breach of peace.

### **ALWAY CONTACT YOUR**

Specific laws give the Gardaí specific powers of arrest as well. For example, a Garda can arrest you under the Road Traffic Acts without a warrant if he/she suspects that you are committing an offence in relation to drinking and driving.

Entry and search of a premises to carry out an arrest.

If a Garda has obtained a warrant to arrest you, he or she may enter and search any premises where he or she suspects you to be. He or she must identify himself or herself, demand

Procedure after Arrest Once you are charged and cautioned, you must be • released on bail by the member in charge of the station (a form of bail known as station bail) • transferred from the Garda Station to the District Court as soon as reasonably possible. If

# Court reserves judgment in trial of man accused of IRA membership

The Special Criminal Court has reserved judgment in the case of a 68-year-old Dublin man accused of IRA membership.

Barry Fitzpatrick, who represented himself during his trial, has denied membership of an illegal organisation, styling itself on the Irish Republican Army, otherwise Oglaigh na hÉireann, otherwise the IRA, in January last year.

The court heard that Fitzpatrick, of Ashlawn Park, Ballybrack, was arrested on January 4, 2009, after gardaí had observed him for several hours driving his grey Honda Accord between the Silver Tassie pub and an apartment complex in Loughlinstown, in the company of two men. Gardaí intercepted and arrested Fitzpatrick as he tried to gain access to the "Ramparts" apartment block in Loughlinstown, just after 10pm that night.

As they were executing a search warrant, a man emerged carrying a hold-all which was found to contain five revolvers identical to the type discovered during the search of the green Honda Civic.

During the case, presiding judge Mr Justice Paul Butler, observed that a senior Garda witness, Chief Superintendent Peter Kirwan, had failed to affirm whether he believed Fitzpatrick was a member of an illegal organisation.

The Chief Superintendent had told the court he believed Fitzpatrick was an IRA member based on confidential information given to him, but not based on any information gleaned from his arrest and detention.

At the conclusion of evidence, Mr Justice Butler asked Fitzpatrick if he wished to call any witnesses or give a sworn statement to the court.

"I don't really have anything else to contribute," Fitzpatrick replied. There were no closing speeches in the case as the prosecution does not have the right to close a trial in circumstances where the accused is unrepresented. Fitzpatrick was asked if he wished to say anything to the court, but he replied: "I'm happy as it is."

He also drove in convoy with a green Honda Civic car, which was later stopped and searched by members of the Special Detective Unit, who discovered two ME .38 calibre sportwaffen revolvers and ammunition in the vehicle.

The court reserved judgment in the case to a date later in the month and remanded Fitzpatrick on continuing bail.

It was with sad regret that the Republican movement Limerick heard of the death of Jack Moore.



Whilst, the Republican was being interrogated the plainclothes officer asked the Republican did he remember him. The Republican then realised that he was previously targeted by the very same officer in Newry where he had previously tried to recruit him as an informer, he was offered a large sum of money on both occasions. In fact, in the airport, the interrogator went to the lengths of placing the large sum of money on the table in front him. Needless to say the Republican did not take the Saxon shilling.

We urge anyone who has been approached by the Crown Forces or indeed the Free State in similar circumstances to contact the Republican Movement.

The Crown Forces have clearly haven't learnt the age old lesson that "It's not those who inflict the most, but those who endure the most who will conquer"

This upsurge in the targeting of Republicans has been met with an upsurge in resistance. Republican youths in the Derrybeg, Carnaget and Springfarm areas of Newry have been constantly engaging in acts of resistance whenever the Crown Forces enter these areas. 
