# ORDUITHE SEASTA

1. Nuair a ghlacann an Ard-Fheis leis na hOrduithe Seasta, ní mór móramh dhá dtrian de na teachtaí atá i láthair len iad a chur ar fionraí.
2. Glacfar leis an gClár ag tosach na hArd-Fheise.
3. Glacfaidh an Ard-Fheis le Coiste Stiúrtha.
4. Beartóidh an Coiste Stiúrtha cé méid ama a thabhairfear do gach roinn agus an méid cainteoirí a mbeidh cead cainte acu.
5. Ceadófar cúig nóiméad don úrlabhraí le roinn a chur i láithir agus trí nóiméad leis an roinn a chríochnú.
6. Ceadófar do dhuine atá ag moladh rún labhairt ar feadh cúig nóiméad. Tabhairfear trí nóiméad do mholtóir agus cuiditheoir rún nó leasaithe le freagairt sula gcuirtear an rún ós comhair na hArd-Fheise.
7. Ceadófar trí nóiméad an duine do gach cainteoir ar rún nó ar leasú.
8. Caithfidh gach cainteoir a ainm agus ainm a chumann, srl, agus an ceantar a lua sula labhrann siad.
9. Nuair a moltar an rún *“go gcuirtear an cheist”*, ní bheidh de rogha ag an gCathaoirleach ach an rún a chur roimh na teachtaí. Má ghlactar leis an rún, caithfidh an Cathaoirleach, tar éis trí nóiméad cainte a cheadú don moltóir agus don gcuiditheoir (ar rún nó leasú), mar a luaitear i (6) thuas, an rún nó an leasú a chur chun vóta. Vótáilfear ar leasaithe ar an rún ar dtús agus ansin ar an rún ina iomlán.
10. Caithfear gach leasú a thabhairt i scríbhinn don gCoiste Stiúrtha ar a laghad 15 nóiméad sula dtosnaíonn an roinn ar leith atá i gceist. Má chiallaíonn an leasú a mhalairt iomlán den rún atá i gceist, ní ghlacfar leis.

# STANDING ORDERS

1. Once adopted by this Ard-Fheis, it shall require a two-thirds majority vote of the delegates present to suspend Standing Orders.
2. The Clár shall be agreed at the commencement of an Ard-Fheis.
3. A Steering Committee will be approved by an Ard-Fheis.
4. The length of time allocated to each section, and therefore the number of speakers, will be decided by the Steering Committee.
5. The policy spokesperson introducing each section shall be allowed five minutes and three minutes to conclude.
6. The proposer of a motion shall be allowed to speak for five minutes when proposing a motion. The proposer and seconder of a motion or an amendment shall be given three minutes to reply before the proposal has been put to an Ard-Fheis.
7. All other speakers to a motion or an amendment shall be allowed to speak for three minutes each.
8. Delegates when speaking must give their names and the name of the body and areas they represent.
9. On the motion being moved *“that the question be put”*, the Chair shall have no option but to put the motion to a vote of delegates. In the event of the motion being carried, the Chair, after allowing the proposer or seconder of the resolution (and amendment, if any) under discussion three minutes as provided for in (6) above, shall have no option but to put the resolution or amendment to a vote.

Amendments to motions will be voted on first and then the motion in its entirety will be voted on.

10. All amendments must be handed in writing to the Steering Committee no later than 15 minutes before the scheduled start of the relevant section. An amendment proposing a direct negative to a resolution may not be moved.

11. Tabhairfear cead isteach do chuairteoirí ar dhíscréid na hArd-Fheise. Tabhairfear cuireadh do chainteoir amháin ó eagraíocht creidiúnaithe ar dhíscréid an Choiste Stiúrtha, le labhairt thar cheann na heagraíochta ar feadh trí nóiméad ar aon rún nó leasú faoi chaibidil, ach ní bheidh cead vótála acu.

Tabhairfear an cead céanna do bhaill tofa Shinn Féin.

12. Caithfear glacadh le rialú an chathaoirligh i gcónaí. An taon bhealach le cur in aghaidh rialú an chathaoirligh ná go nglacfaí le rún miontaofachta sa chathaoirleach nó trí orduithe seasta a chur ar fionraí.

13. Áit a mholfar Orduithe Seasta a chur ar fionraí ar mhaithe le rún éigeandála, caithfear an rún sin a thabhairt i scríbhinn don gCoiste Stiúrtha maraon leis an chúis atá leis.

14. Ceadófar 'Pointí Oird' ar dhíscréid an chathaoirligh agus ní cheadófar níos mó ná 30 soicind dóibh.

15. Má bhíonn aon eolas ar leith ó aon teachta ar an ábhar faoi chaibideal ní mór é a fhiosrú i scríbhinn ón gCoiste Stiúrtha.

16. Ní cheadófar d'éinne a ainmníotar don Ard Chomhairle a bheith ina áiritheoir.

11. Visitors shall be admitted at the discretion of an Ard-Fheis. One visitor representing an accredited organisation shall be invited to speak at the discretion of the Steering Committee on behalf of that organisation for three minutes on any proposal or amendment under discussion but shall not be allowed to vote.

Sinn Féin elected representatives shall be given the same facilities as accredited organisations.

12. The ruling of the Chair must be accepted at all times. The only way of challenging a decision of the Chair is to move a motion of no confidence in the Chair or by a motion to suspend Standing Orders.

13. Where a motion seeking suspension of Standing Orders is put for the purpose of submitting an emergency resolution, that resolution must be given to the Steering Committee in writing giving reasons for same.

14. 'Points of Order' will be allowed at the discretion of the Chair and shall be limited to 30 seconds.

15. Delegates requiring information on matters under discussion must do so in writing through the Steering Committee.

16. Persons nominated for officership or membership of An Ard Chomhairle shall not be eligible to act as tellers.

## Social & Economic (a)

### Education

We recognise that both systems fail to prepare young people to play a positive role in society and that they fail to invigorate young people to express themselves and communicate with each other effectively. Emigration is an indictment of the economic and social policies of successive Free State governments and of the politicians who make up or support those governments. Despite the failure of their policies, they proceeded knowing that the results would be further unemployment, higher levels of emigration and an increasing loss of sovereignty to foreign banks and US and British interests.

Sinn Fein condemns the present Coalition government for social and economic policies that have produced record levels of emigration. We realise that, for as long as such policies are pursued, thousands of young Irish people will emigrate and many of them will end up unemployed and in hardship abroad. For this reason Sinn Fein believes that support should be given to progressive organisations in the USA and in Britain who try to deal with the hardship faced by Irish emigrants.

In the 26 Counties Sinn Fein will support steps to make young people aware of the facts and possible consequences of emigration.

Sinn Fein believes that to try to help young emigrants in difficult circumstances or to make information available in Ireland on the likely problems which would be encountered on emigration does not amount to a promotion of emigration but is simply a response to hardship caused by the uncaring policies of the Coalition government.

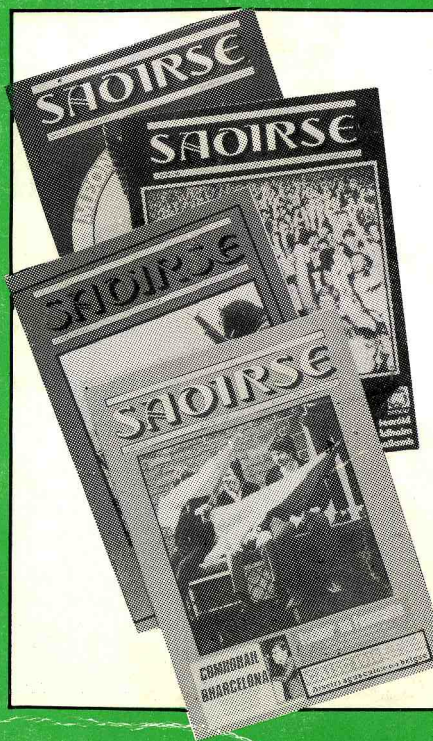
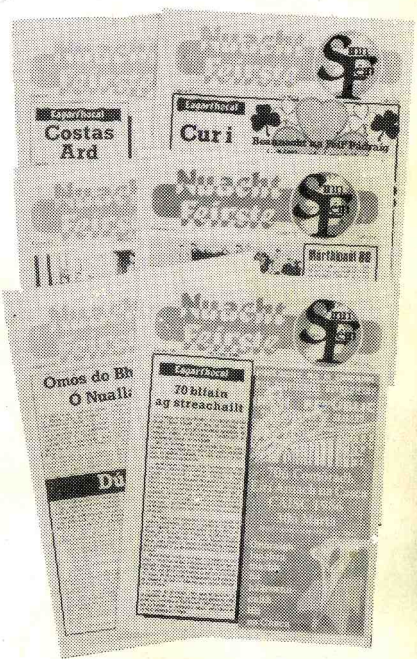


# Nuacht Feirste
